1) October 18th, 2019 (one month before first case reported in Wuhan, China):

- 5) March 11th, 2020: World Health Organization (WHO) declares COVID-19 "Global Pandemic": https://time.com/5791661/who-coronavirus-pandemic-declaration/

11) April 20th: Coronavirus tests (non-specific) done in USA as of April 20th: greater than 5 million. #2 Korea: 400,000

12) April 21st, 2020: 44,575 reported COVID-19 deaths to date by CDC in all 55 jurisdictions. "**Total jurisdictions includes 50 states, District of Columbia, Guam, the Northern Mariana Islands, Puerto Rico, and the U.S Virgin Islands."

Total US population: 331,000,000/44,575 deaths = one in 7,426 Americans have died of COVID-19.
